2. Sun. 7/8 (4) LG for Pryibil , (1) LG for Morgan.
3. Mon. 7/9 (3) LG for Morgan.
4. Tues. 7/10 (3) LG for Morgan.
5. Total: 16 LG positions.

Respectively Requested Salary and Fees:

1. Each Lifeguard at \$20.00/hour.
2. Each Day, Skudin Swim Inc. will charge a \$100 administration fee.
  - a. Administration fee covers logistics and time spent traveling the (1) hour car drive to and fro Glen Cove from Nickerson Beach, Lido, NY 11561.
3. Hours 10am – 6pm.
4. Math:
  - a.  $\$20/\text{hour} \times 8 \text{ hours} \times 16 \text{ LG positions} = \$2560.00$
  - b. Admin Fee:  $\$100 \text{ charge per day} \times (4) \text{ days} = \$400.00$
  - c. Total:  $\$2960.00$
