

**We, the undersigned,**

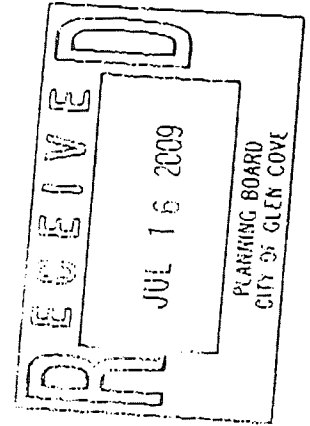
are opposed to the high-density, high-rise development project as proposed for our Waterfront. This petition shows that there is little public acceptance or support for this proposal:

- The proposed development of 16 story towers is out of character with our suburban community.
- There are too many unanswered questions on the suitability of this land for residential development because of its toxicity.
- Our roads cannot support the additional volume of traffic congestion generated by 1,120 residences, and the project is far from public transportation.
- The property sits on a FEMA 100-year flood plane; evacuation of the area would be impossible.
- The tax benefit to the citizens of Glen Cove has not been demonstrated.

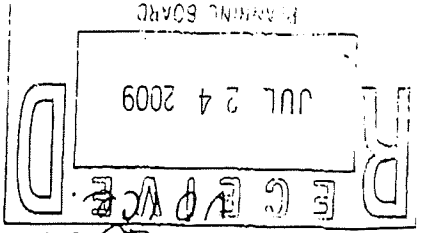
The contract between the CDA (Glen Cove's Community Development Agency) and the Developer states "the Agencies and the developer have agreed that the project be constructed and operated pursuant to the following principles: ... (viii) **To gain broad public acceptance and support.**" (page 8).

This is just the start of this petition. There are the names of 318 people on this page, 50 names have been submitted previously to the Mayor and Planning Board, and 600 signatures were collected last fall. This petition is on-going. 
