Brief Description of Proposed Action (include purpose or need): This application is being made to amend the previously approved PUD Master Plan for the mixed-use development of an approximately 56-acre property located on the north side of Glen Cove Creek. The applicant is seeking to improve the configuration of the parcels and open space in a way that benefits the general public, residents of Garvies Point, and surrounding communities. The proposed PUD Amendment relates to the reconfiguration of Blocks A, D, E, F and J, enhancements to open space throughout the Project, and the expansion of on-site parking capacity ("the Amendment"). The Amendment consists of five components: (1) Reconfiguration of the residential development on Block A, while maintaining the approved 346-unit residential yield; (2) Reconfiguration of the development layout on Block J to provide additional parking and open space without altering the previously approved public amenity elements or building floor area for retail space; (3) Elimination of the 50,000-sf approved office building on Block D; (4) Revision of the approved plan for the multi-building development of Blocks E and F; and (5) Relocation of the 56 workforce housing units that were approved for Block F to a parcel adjacent to the current 56±-acre PUD area.
