APPLICATION FOR TEMPORARY MEMBRANE STRUCTURE, TENT, AND CANOPY PERMIT

For 120 square feet or more

MUST BE FILED NOT LESS THAN FIVE (5) BUSINESS DAYS PRIOR TO EVENT

- A Certificate of Flame Resistance is required with **all applications**.
- Any tent exceeding 1,200 square feet and all tents located in the inner fire limits, require a Tent Permit from the Nassau County Fire Marshal and a Building Permit from the City of Glen Cove Building Department.
- All tents with less than 12 feet clearance between tents will be considered as a single tent.

Tent permit fee of **\$125.00** is per tent. Permit is not to exceed one hundred eighty (180) days.
One application per TENT to be used.

In order to obtain a permit, the following information must be provided:

A minimum **2A:10BC** portable fire extinguisher shall be provided in all tents. See chart below for number of extinguishers required based on square footage:

0 to 499 sq ft = 1	3001 to 5000 sq ft = 4
500 to 1000 sq ft = 2	5001 to 7000 sq ft = 5
1001 to 3000 sq ft = 3	7001 to 9000 sq ft = 6

If the tent is used as an assembly (**more than 49 persons**):

1. If used after sundown, exit and emergency lighting must be provided.
2. If assembly capacity is more than 1,000 people, a City of Glen Cove fire watch must be provided.

If “yes”, a City of Glen Cove firewatch must be provided and fire extinguisher(s) with a minimum rating of 3A40BC shall be provided near cooking equipment.

The plot plan or layout shall indicate where cooking equipment will be located

Smoking shall not be permitted in tents, canopies, tarps, or membrane structures. Approved “**No Smoking**” signs shall be conspicuously posted.

Applicant shall comply will all provisions of Chapter 31 – of the International Fire Code (Tents, Canopies, and other Membrane Structures)

This permit shall be issued upon completion of a site inspection by an Inspector.
